ROCKMARATON 2025 FESTIVAL HOUSE RULES 2025.

The House Rules for the ROCKMARATON festival contain the mandatory entry and conduct rules.

The rights and obligations arising from the legal relationship between the Organizer and the persons entering the Event (Visitors) are contained in the General Terms and Conditions (hereinafter: GTC).

Event location: 2400 Dunaújváros, Szigeti út 1.

I. ADMISSION TO THE EVENT

- 1./ Entry to the Event is possible within the time frames and under the conditions specified in the ticket.
- 2./ The Visitor must wear the wristband at all times during the validity period. This will be checked by the organizers upon entry and exit, and continuously in the Event area. If the Visitor's wristband is invalid, he/she must leave the Event area. The wristband is not transferable. A damaged wristband glued over, cut, larger than the palm of the hand, or manipulated in any other way is invalid. A damaged or lost wristband cannot be replaced or exchanged. The Organizer will initiate proceedings against ticket counterfeiters and those who assist in counterfeiting. The Organizer has the right to refuse entry to any person who is in a condition that endangers the proper conduct of the Event or the safety of the Visitors and property.
- 3./ In order to ensure the safe conduct of the Event, the Organizer reserves the right to restrict the objects and devices that can be brought into the Event area. In particular, it is prohibited to bring into the Event area drugs, pyrotechnic devices, glass objects, umbrellas, objects or devices containing explosive, toxic or flammable substances, as well as firearms, knives or other objects that are particularly dangerous to public safety as defined in Government Decree 175/2003. (X. 28.) on devices that are particularly dangerous to public safety.
- 4./ The Visitor is not entitled to bring alcoholic beverages into the Event area. In the event of a heat alert issued by the National Weather Service, (mineral) water may be brought into the Event area in quantities reasonably necessary to satisfy personal needs. The Visitor is not entitled to bring food or tobacco products into the Event area in commercial quantities.
- 5./ Children under the age of 12 (twelve) can attend the event free of charge, but they are also required to wear a child wristband. The chaperone is required to write the child's name and the chaperone's telephone number on the child wristband. Child wristbands can be requested upon entry.

Children under the age of 16 (sixteen) may only enter the Event area with an adult adult chaperone and may only remain there with an adult adult chaperone.

- 6./ Disabled people with a valid ID card from the following organizations can attend the Event with a 50% discount with 1 accompanying person. The accompanying person is responsible for the person being accompanied during their stay at the Event. In order to prevent abuse, we ask our disabled guests to prove their disability with their ID card. We only accept valid ID cards from the following organizations: National Association of People with Intellectual Disabilities (ÉFOÉSZ), National Association of Hungarian Blind and Visually Impaired People (MVGYOSZ), National Association of the Deaf and Hard of Hearing (SINOSZ), National Association of the Deaf-Blind (SVOE), National Association of Associations of the Mobility Impaired (MEOSZ), National Association of Autistic People (AOSZ).
- 7./ It is prohibited to enter the Event area with a vehicle without a permit issued by the Organizer. Even persons with a permit are required to fully comply with the provisions of the Road Traffic Act at the Event.
- 8./ No animals other than assistance dogs, guide dogs and police dogs as defined by law may be allowed into the Event area.

II. RULES OF CONDUCT

1./ The Visitor is obliged to behave in the Event area in accordance with the general norms and in accordance with the relevant legal provisions, the GTC and the house rules. The Visitor is obliged to refrain from any manifestation, communication or action that may endanger or violate the personal rights, life, health or physical integrity of others. The Visitor is particularly obliged to protect natural values in the Event area and is obliged to refrain from damaging them.

- 2./ The Visitor acknowledges that the Event may be recorded in audio and video by the Organizers and press personnel (in accordance with the provisions of the separate contract applicable to them), other Visitors. Accordingly, by participating in the Event, the Visitor expressly consents to the recording and publication of his/her face, appearance, and expressions, provided that he/she may only be named with his/her express consent. If the Visitor is considered a public figure, he/she may be named without his/her consent. The Organizer is entitled to utilize, use, publish, and publicize the presentation without restriction in relation to the Visitor.
- 3./ Any economic, commercial or advertising activity is prohibited within the Event area including the area in front of the entrance to the Event without the prior written permission of the Organizers.
- 4./ It is prohibited to serve alcoholic beverages to persons under the age of eighteen and to intoxicated persons in commercial and catering establishments on the premises of the Event. The consumption of substances that are considered narcotics under the applicable laws is also prohibited on the premises of the Event and is punishable by law.
- 5./ Given that the purpose of the Event is to provide cultured and undisturbed entertainment for Visitors, any demonstrations not related to the event are prohibited at the Event.
- 6./ The audience may be exposed to extreme sound and light effects at the Event, so visitors who are sensitive to this should stay at a suitable distance from the stage.

III. OTHER PROVISIONS

- 1./ The Organizer is solely liable for intentional breach of contract attributable to it, as well as for damage to human life, physical integrity or health, and, in addition to the rights of the Visitor under the law, expressly excludes liability for any other damage.
- 2./ The Organizer operates a luggage storage facility at the Event, and accordingly assumes liability only for the items placed there, up to a maximum of HUF 15,000. The Organizer does not assume the custody of valuables and cash. The Organizer does not provide security in the designated parking lots, therefore the Organizer is not liable for the vehicles parked there and the items placed therein.
- 3./ The Organizer may hold the Event even in bad weather. The Event or a part of it will not be held if the Organizer is obliged by the authorities to suspend or close it due to a force majeure event.
- 4./ The Organizer reserves the right to change the program. The Organizer is not responsible for changes resulting from mistakes or accidents of the performers.
- 5./ The Visitor who is present at the Event area with or without a wristband that does not entitle him to stay there, acknowledges and accepts that he must pay the price of the wristband that entitles him to stay (or the corresponding difference) at the same time as being held liable. Otherwise, he is not entitled to further visit the Event and cannot make any claims or demands in this regard.
- 6./ Found items can be dropped off at the left-luggage office, and lost items can also be inquired about here.
- 7./ It is illegal to produce, distribute, use and promote drugs in Hungary. It is strictly forbidden to bring any substances classified as drugs to the Rockmaraton festival!
- 8./ By purchasing a ticket, each Visitor accepts the Event Rules and acknowledges that they are mandatory to comply with at the event. Otherwise, the Organizer may remove them from the event venue without compensation.
